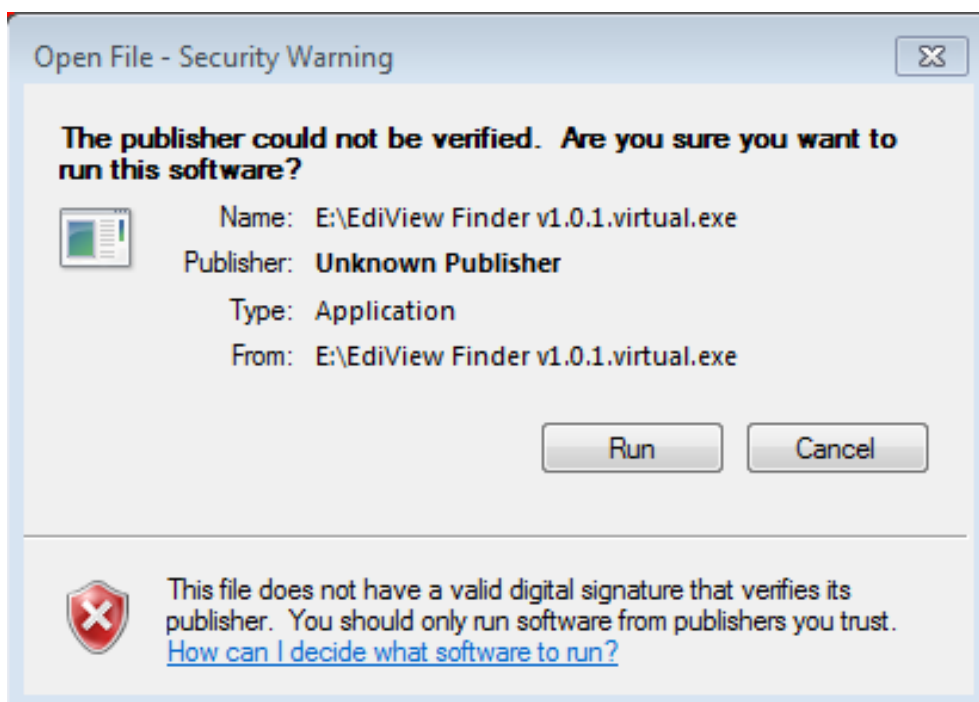
2. Wenn Sie ein drahtloses Modell haben (IC 3110W), schließen Sie die Antennen an den Antennensockel an.
